#### WHAT WE DO

#### **THE DANGERS**


When a drug user has contaminated your vehicle, the drug residue and unsuccessfully discarded drug paraphernalia, such as used needles, glass pipes, and baggies, can have permanent, adverse effects on the innocent. Anything as small as the hypodermic needle used can easily penetrate someone's skin, potentially endangering the health of the victim with unknown pathogens and drug residues. Broken crack pipes can cut the skin and cause infections, or allow traces of drugs to enter the bloodstream of an individual. And even a seemingly harmless object such as a baggie can contain ample drug residue to cause serious harm to children or pets.

### **VEHICLE DRUG DECONTAMINATION**



To decontaminate a harmul drug contaminated vehicle, our specialists follow these steps:

#### **1. VISUAL INSPECTION FOR SHARPS**

As soon as Juvenaire receives a suspected methamphetamine contaminated car, our technicians first need to inspect it for sharps.

#### **2. PACKING PERSONAL ITEMS**

If there are any personal goods remaining in the car, our team will take them away and store them in bags.

#### **3. DRUG TESTING**

The damages aren't physically visible. This is why, BEFORE proceeding with an expensive cleaning process it is very important to undertake testings to ensure whether the vehicle is contaminated or not. If the results come back positive, it is highly recommended that the car is professionally cleaned.

**Note:** Vehicle drug decontamination can be very expensive. Testing your vehicle could save you a lot of money.

#### **4. POSITIVE DRUG TESTING**

If the vehicle tested is contaminated by Meth or Fentanyl, the Car Salon hazrdous cleaning team will provide a quotation along with a report to inform the insurance company of the costs.

#### **5. CLEANING PROCESS**

A Meth or Fentanyl contaminated car requires a thorough cleaning. To clean the toxic chemicals from methamphetamine, the seats need to be removed and treated. The interior of the auto is then disinfected and sanitised.

The vehicle may need to be treated several times depending on the level of contamination.

#### **6. SECOND TESTING**

It is very important to proceed with another testing after the cleaning of a Methamphetamine or Fentanyl contaminated automobile. This second testing will indicate to us if the car has been decontaminated and is ready to be handed back to the owner.
